The Harvard (College) China Forum was founded at Harvard University in 1997 by Mr. Bo Li and Mr. Ligang Zhang. For the last twenty-five years, the Harvard College China Forum has endeavored to promote understanding and build a bridge based on mutual respect and equality between China and the rest of the world. Every year, the forum convenes leaders in politics, business, academia, and entertainment to discuss international affairs and the future of China's development. After twenty-five years, the Harvard College China Forum has grown into the largest and longest-running student-organized China summit overseas, with more than one hundred speakers and over a thousand audience members attending each year. Despite the ongoing pandemic and a continuously-evolving international situation, the Harvard College China Forum has remained faithful to its original mission of building consensus and discovering new areas of cooperation through dialogue.

On the occasion of the twenty-fifth anniversary of its founding, the Harvard College China Forum will once again return to Harvard's campus, gathering friends from across the globe on the banks of the Charles River for a long-awaited exchange of ideas.

不凡岁月 砥砺前行

五十年前,时任美国总统尼克松访华,两个世界大国实现了第一次"跨洋握手",成就中美外交史上的"破冰之旅"。随后《上海公报》的签署开始了中美两国互相尊重,合作共赢的新篇章。五十年后,北京冬奥会开幕式上,"冰雪五环"破冰而出的设计同样寓意着打破隔阂,携手共进。五十年来,世界局势经经历了翻天覆地的变化,中国亦从封闭走向开放,并通过与世界各国的双赢合作,逐步成长为引领时代的大国强国。五十年间,虽然中美关系历经波折,但是两国间的合作不断加深,两国在经济、能源、科技、环保等诸多领域存在共同利益也不断扩大。

站在新的历史起点,放眼下一个五十年,但凡融冰初心不改,在不凡岁月中,亦可砥砺前行。中美两国民间的交流从未因时局的变迁而有所停滞。五十年前,非官方渠道的文化交流和民间外交冲破了两国意识形态上的分歧;五十年后的今天,中美学术、商业、文化、体育上的来往也必将成为两国共同前行的坚实基础与推动力量。

不凡岁月,挑战与机遇交织,冲突与共识并存。我们衷心期盼两国共担责任、同谋发展、砥砺前行。

Extraordinary Times

Fifty years ago, U.S. President Richard Nixon's visit to China broke the ice after two decades of hostile relations. Culminating in the signing of the Shanghai Communiqué, this diplomacy laid the foundation for a new chapter of U.S.-China relations characterized by greater respect and cooperation.

At the opening ceremony of the 2022 Beijing Winter Olympics, five Olympic rings emerged from the Bird's Nest stadium, rising steadily from beneath the solid ice floor and breaking barriers once more fifty years on. This past half-century has witnessed unprecedented changes for the world, with China taking major steps to open its economy and evolving into a leading global power. Although this relationship has not been without ups and downs for this past half decade, cooperation between the two countries has also deepened, and despite recent tensions, their interests—economic, scientific, technological, and environmental—remain deeply intertwined.

We are faced with challenge and conflict, but are not without opportunity and consensus. Indeed, people-to-people exchange between China and the U.S. has remained strong regardless of political circumstances. Fifty years ago, informal cultural exchanges and diplomacy transcended the ideological differences between the U.S. and China. Fifty years later, our exchanges in the academic, commercial, cultural, and athletic realms continue to push us towards closer ties. We sincerely hope that our two countries can continue to shoulder their responsibilities to each other and the international community and forge ahead amidst these extraordinary times.



Domestically, a resurgence of COVID-19 cases and stock market turbulence have brought about economic uncertainty. Globally, China faces pressure from inflation and rising commodity prices, both of which have been exacerbated by the Ukraine crisis.

Saturday April 16, 2022 10:40-11:40 HBS Spangler Auditorium 新能源汽车在各国国家层面都已得到了广泛的支持。其中,美国政府声明称将延续新能源汽车购买的激励措施并增强充电基础设施的配置。在中国,支持性的产业政策、产品的多样性和持续增长的客户需求也不断推动着新能源汽车行业的发展。尽管如此,近期的国际政治动荡以及能源和原材料价格的飙升为电动汽车行业的未来发展趋势增加了多层不确定性。

本场新能源汽车分论坛将汇聚中美行业专家,就新能源汽车行业的前景、可预见的挑战和未来的机遇提供见解。

The electric vehicle (EV) industry has received broad government support around the world. In the United States, the Biden administration expanded the EV incentive program, issued favorable fuel-economy regulations, and allocated federal funds for building critical charging infrastructure. In China, regulatory bodies have continued to promote domestic EV companies, like NIO and XPeng, in accordance with the Party's broader "Made in China 2025" industrial policy. However, the global political instability caused by the Ukraine crisis and the surge in energy and raw material prices have created new reasons for uncertainty.

This panel welcomes industry leaders from the U.S. and China to discuss the landscape of the American and Chinese EV industries, foreseeable challenges, and future opportunities.


Saturday April 16, 2022 10:40-11:40 HBS Aldrich 112 区块链的应用场景已逐渐丰富。单一加密货币已演化出 NFT、加密游戏、去中心化金融等多种形式与应用场景。尽管 国内产业界早在2020年已对区块链技术表示肯定,但如今社 会对其整体态度仍不一致。同时,国内有关政策也在逐步演 化,例如,兼具加密货币特征的的数字人民币正被不断普及。

本场区块链分论坛将汇聚该领域的投资人、创业者及专家,共同探讨全球性去中心化技术变革,web 3.0的兴起,及 其区块链技术对国际宏观经济的影响。

The blockchain has evolved in purpose and implementation from simple cryptographically-secured currency to complex programmable assets and art installations. China's fluctuating regulatory landscape on cryptocurrencies, however, leaves the future of blockchain in China ambiguous. What are the major regulatory and other adoption challenges that cryptocurrencies face globally? Will the digital yuan succeed, and will China reverse its mining ban? Will new technological breakthroughs in cryptocurrency—DeFi, NFTs, GameFi, L2s—affect China's stance? What does the rise of web3.0 mean for China in the context of international macroeconomics?

This panel will bring together crypto investors, entrepreneurs, and key opinion leaders to discuss the challenges ahead for blockchains and cryptocurrencies.





虽然中美两国在2020年初达成了第一阶段的贸易协议,但美国对华关税税率仍处在数十年来的高位上。拜登总统近来恢复进口关税豁免的决定或许只能说明两国在网络安全及其他市场准入领域的更深层次争端仍未得到解决。

Despite both countries reaching a Phase One trade agreement in early 2020, tariff rates remain at a multi-decade high. This keynote panel gathers former trade negotiators and economics experts to discuss the next steps for resolving the trade war and the stakes of a resolution.






